Ram Inspection/Registration 2026 (Form RR1)

Members are asked to complete their applications (Online Flock Book & Registry preferred – login details on forms). **Only complete applications with full payment will be accepted. Late entries will not be accepted, hence will not be eligible for registration.**

What you need to do now to notify your shearling (2025 born) rams for Inspection/Registration

- Enter your rams for one of the below inspection centres, either, via the Online Flock Book & Registry, email a spreadsheet or use the enclosed paper forms.
- Note the rules and regulations can be viewed online or please contact the office to obtain a copy.
- Ensure the correct payment is sent to the office, (preferably by BACS) by the closing date. UK members = £31.20 inc. VAT (Ireland members = €30.15 net VAT or €36.20 inc VAT – depending on your VAT status)
- Closing date for SHEARLING RAM APPLICATIONS (see last column below)
- LATE ENTRIES WILL NOT BE ACCEPTED and will NOT BE ELIGIBLE FOR REGISTRATION

LLEYN SHEEP SOCIETY ARE WORKING WITH INNOVIS - TO HAVE YOUR RAMS DNA TESTED

Below you can see what are the benefits of having your rams DNA tested. This service is offered by Innovis for the Lley Sheep Society members. If you are interested, please note that you will have to ring Innovis direct to request a kit on **01970 828236** or through the Innovis website (<https://www.innovis.org.uk/services/genotyping-service/>). The deadline for submitting the kit to Innovis will be **Wednesday, 1st July, 2026**, in order to guarantee that the results will be back in time for all the Autumn sales.

Please consider this offer and hopefully you will benefit from the results.

Below I quote from an e-mail the Society have received from Janet Roden, Geneticist at Innovis Ltd. Dated 21st April, 2026. "We are delighted to collaborate with the Lley Sheep Society to offer the Ram (DNA) Genotype Service to members, in partnership with **GenomNZ**. We have collaborated closely with GenomNZ for the past seven years across other areas of our business and have complete confidence in their ability to deliver a first-class, reliable genotyping service. All samples will be analysed in New Zealand using an **80,000 SNP assay** developed by **AgResearch** and supported by decades of national and international research. This platform enables the sheep industry to benefit from validated scientific discoveries across both New Zealand and UK flocks, while ensuring full global SNP compatibility.

As part of the service, members will receive:

- Scrapie genotypes (with certificate)
- Eight additional marker tests (see below) including tests to GDF-8 muscling (often known as MyoMAX), prolificacy genes (including FecXG) and genes currently under investigation in relation to relative resistance/susceptibility to Maedi Visna)
- The ability to verify parentage and pedigree for a small additional charge

In addition, full the genomic profiles will be shared with Signet for the development of genomic breeding values, and the results of the gene tests will be made available to the Society to allow monitoring of genotype frequencies in the breed. This will bring considerable benefits to the whole breed.

The price for this service is **£18.50 per sample**, excluding the cost of the sampling kit. This price is the same for any number of samples submitted and is exclusive to the Lley Sheep Society Ram (DNA) Genotype Service. In order to access this price and take part in the scheme **please ring the Innovis office (01970 828236) to order your genotype test.**

Members may take their own samples and will return them directly to Innovis. The new service requires the use of the **Allflex Tissue Sampling Kit**. This kit is already widely used in our breeding programmes and is commonly adopted for BVD testing in cattle. You can order the sampling kit from Rosemary in the Innovis office, or through the Innovis website (<https://www.innovis.org.uk/services/genotyping-service/>). Innovis can provide an applicator on loan if needed.

The new service operates with a **six-week turnaround time** from sample submission to the return of results. We therefore encourage members to collect samples well ahead of sales. Samples will be dispatched to New Zealand on the **second and fourth Thursday of each month.**

What are the 9 marker tests?

1. Scrapie
2. BCO2 – Yellow Fat - The BCO2 gene produces an enzyme that is required for the breakdown of yellow pigments absorbed through the animal's diet. If sheep have two copies of the variant of the BCO2 gene, where the enzyme is not active causing the pigment to build up in the animal's cells resulting in carcasses with yellow fat.
3. GDF8 – MyoMAX - The GDF8 gene regulates muscle growth. A specific variant of the gene originally from the Texel breed impairs this regulatory function and causes an increase in muscle production and a decrease in fat production.
4. GDF9 – Number of Lambs Born - The GDF9 gene has been found to be associated with increased ovulation rate in a number of sheep breeds.
5. PITX3 – Microphthalmia - A mutation in this gene, typically seen in the Texel breed and their crosses, causes extremely small or missing eyes and subsequently blindness if the animal carries two copies of the mutation.
6. BMPR1B – Booroola - Booroola sheep have a mutation that in the BMPR1B gene increases ovulation rate and litter size in sheep.
7. FecX(I) – Inverdale - The Inverdale FecXI mutation occurs in the BMP15 gene on the X chromosome and increases the ovulation rate and litter size in heterozygote females (one copy of FecXI) but causes infertility in homozygotes (two copies of FecXI).
8. TMEM154 – putative association with MV resistance/susceptibility - A number of studies have suggested that several mutations in this gene are associated with relative resistance or susceptibility to Maedi Visna infection. Evidence suggests that there is not an absolute relationship, but the two genotypes reported may reduce the probability of testing positive when virus is known to be circulating in a flock.
9. FecX(G) – prolificacy - FecXG (Galway) is a mutation in the BMP15 gene on the X chromosome that is associated with exceptional prolificacy in sheep, homozygotes (two copies of FecXG) causes infertility in females. This mutation behaves in a similar manner to the Inverdale mutation."
