Ram Inspections/Registration 2021 (Form RR1)

I writing to you today as it is proposed to undertake the ram inspections during June/July. We will however be monitoring the situation and we will inform you immediately if the circumstances changes. Members are asked to send in their applications (forms enclosed or via online Flock Book & Registry or send a spreadsheet) for registration/inspection as usual, noting the venue (see below) you intend to take the rams. Please note we are operating with two different closing dates for the different centres. **Only complete applications with full payment will be accepted. Late entries will not be accepted (hence will not be eligible for registration).**

What You Need to do Now to Notify your Shearling (2020 born) Rams for Inspection/Registration

- Enter your rams for one of the below inspection centres, either via the Online Flock Book & Registry, send a spreadsheet or use the enclosed forms.
- Note the Rules and regulations can be viewed online or please contact the office to obtain a copy.
- If you intend to use the Ram DNA Scheme to obtain gene information you must enter your rams online or by a spreadsheet. Sorry paper application forms cannot be accepted.
- Ensure the correct payment is sent to the office, (preferably by BACS) by the closing date. UK members = £30 inc. VAT (Ireland members = €35 net VAT or €42 inc VAT – depending on your VAT status)
- Note the closing date for SHEARLING RAM APPLICATIONS (see last column below)
- **LATE ENTRIES WILL NOT BE ACCEPTED and will NOT BE ELIGIBLE FOR REGISTRATION**
- The Society should be in a better position to advise members after the closing date how we will proceed with these inspections and registrations for this year. Our intention is to uphold Society standards whilst processing your registrations in the most efficient way possible during this very unusual period.

These venues are subject to change. If there are insufficient numbers entered for any venue, it may be cancelled. Breeders with rams entered for a venue that becomes cancelled will be asked to take them to another venue.

Ram DNA Scheme (Must be done online or via spreadsheet)

If you wish to take part in this scheme to obtain gene information about your rams, you must enter you rams via the [Online Flock Book & Registry](#) or by the [Spreadsheet](#) method. Please see further details in the newsletter, or please contact the Society staff.

Ewe Lamb Registrations (Form RE1)

Enclosed is a form for you to register this year's (2021) crop of ewe lambs, you can do these registrations online or via a spreadsheet – please note:

- if you are selling ewe lambs at one of the official sales then you must register these at the same time (or before) you are entering the sheep to the society sales. Be aware the Society will be doing spot checks at the sales!
- Your lambs must be tagged according to DEFRA (or equivalent governing body) and Society rules
- The final closing date for receiving applications to register 2021 born ewe lambs is 31st December. Note the registration price increases after 31st October. Please see chart below for the fees.



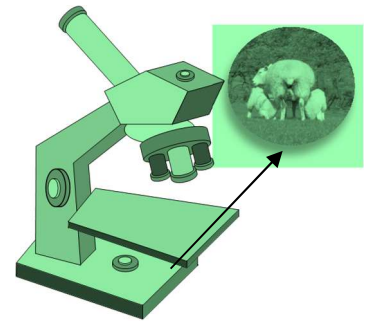
