



## Ewe lamb registrations 2018

Enclosed is a form for you to register this year's crop of ewe lambs – please note :

- a) **if you are selling ewe lambs at one of the official sales then you must register these at the same time as you are entering your sheep to the sales and tagged according to DEFRA (Ireland to comply with your tagging rules) and Society rules.** A Panel will be doing spot checks to ascertain that members have registered their ewe lambs which they intend selling at that particular sale.
- b) that the closing date for receiving applications to register all other ewe lambs is **31<sup>st</sup> October, 2018** with **31<sup>st</sup> December, 2018** being the deadline for registering 2018 ewe lambs.


